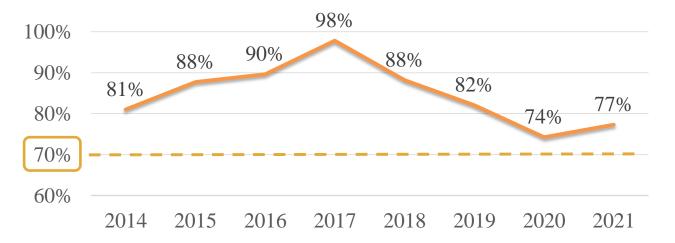
Stable Profits (EBIT: Individual)



Stable Dividends

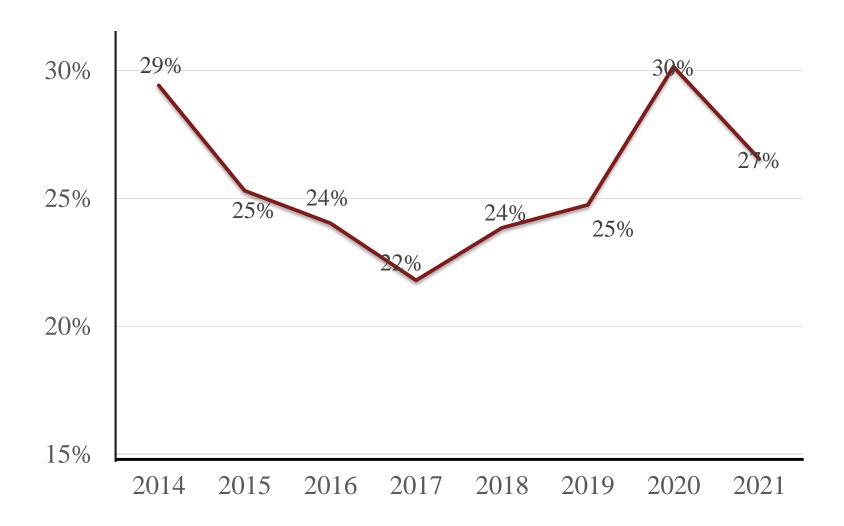


Payout Ratio
